

### **Notice Regarding Civic Amenity Sites**

All Local Authorities are taking individual decisions in respect of ongoing operation of civic amenity sites during Covid-19 restrictions. We will update on a regular basis the status for each Local Authority area below and current status of site operations.

### **Update: Thursday 7<sup>th</sup> May 2020**

#### **Galway County Sites**

**The sites in Ballinasloe, Clifden and Tuam will re-open to the public from MONDAY 11<sup>th</sup> May 2020 and normal opening times will be in operation therefore Tuam and Clifden will re-open from Monday and Ballinasloe from Tuesday under normal days / times as before lockdown. Please note sites will function as normally as possible but social distancing measures will be in place with limited vehicles being allowed in at the same time therefore please respect the Site Managers instructions exercise patience and care while using the sites. This policy may result in extra queues during busy times therefore please don't queue onto public roads come back at a less busy time if needed. The sites have been closed since Tuesday 31<sup>st</sup> March and we will update on any future changes here.**

#### **Athlone**

The site run in conjunction with Westmeath County Council at Golden Island Shopping Centre, Athlone is also operating a normal schedule during the current Covid-19 restrictions. We encourage people to use the facilities for essential business only and respect the travel guidelines in place.
